Basic Services of Director & Staff includes, but is not limited to, staff to respond to initial request for service; arrangement conference with family and responsible parties; arrangement of funeral; preparation and filing of necessary authorizations and permits; recording vital statistics; placement of local obituary notices; and coordination with those providing other portions of the funeral (e.g., cemetery, crematory, vault company and others as required). Also included in this charge are overhead expenses relative to our facilities such as professional licensing; legal and accounting fees; insurance; utility expenses; building, parking lot, and grounds maintenance; taxes; equipment; furnishings; inventory costs; and record-keeping, secretarial, and administrative expenses. This fee will be added to the total cost of the funeral arrangements selected.

2. Local transportation of the deceased from the place of death to the funeral home.

3. Generally includes Dressing, Casketing, and Cosmetology

4. Funeral homes owned and operated by the funeral conglomerate Service Corporation International (SCI) of Houston, Texas. When you call on one of these funeral homes, your loved one is transported to their shared preparation facility (formerly known as “Colorado Springs Mortuary and Cremation Services”) at 3475 Astrozon Court. All essential professional services including refrigeration, embalming, dressing, casketing, cosmetology, hair care, and cremation services are performed at this industrial-park, warehouse facility. In comparison the Shrine of Remembrance provides all professional services through our on-site preparation, refrigeration and crematory facilities at our Main Chapel Mausoleum located at 1730 E. Fountain Blvd.
